

**“Raikan legasi 40 tahun PETRONAS Sprinta”  
TERMS AND CONDITIONS**

1.0 Organizer:

- 1.1 PETRONAS Lubricants Marketing (Malaysia) Sdn Bhd (“PLMM”) is the organizer of this “*Raikan legasi 40 tahun PETRONAS Sprinta*” (“Contest”).
- 1.2 The following terms and conditions apply in respect of this Contest. By participating in this Contest, you agree to be bound by these terms and conditions, including any amendments made from time to time, without limitation or qualification (“**Terms and Conditions**”).

2.0 Eligibility:

- 2.1 The Contest is open to all Malaysian citizens, subject to fulfilling ALL the following requirements:
  - 2.1.1 Participants must hold Malaysian citizenship; and
  - 2.1.2 Participants must be aged eighteen (18) and above.

Any individual who meets all the above-mentioned requirements shall be hereinafter referred to as “**Participant**” or “**Participants**”.

- 2.2 The following individuals are **NOT ELIGIBLE** to participate in the Campaign:
  - 2.2.1 Permanent or contract employees of the PETRONAS Group of Companies, including the Organizer and their immediate family members (including fathers, stepfathers, mothers, stepmothers, siblings, spouses, children, stepchildren and adoptive relationships);
  - 2.2.2 PETRONAS station dealers, PETRONAS crews and their immediate family members (including fathers, stepfathers, mothers, stepmothers, siblings, spouses, children, stepchildren, and adoptive relationships); and
  - 2.2.3 Employees of third-party service providers of the Organizer, their permanent and/or contract employees, and their immediate family members (including fathers, stepfathers, mothers, stepmothers, siblings, spouses, children, stepchildren, and adoptive relationships).

In the event a Participant is found to be ineligible at any point of time during or after the Campaign Period as set out hereinbelow, the Organizer reserves the right, at its sole discretion, to disqualify the said Participant and to cancel, withdraw and/or to recall any prize awarded to the said Participant. In the event where the said Participant has benefitted from the prize, the said Participant agrees and undertakes to reimburse the Organizer for the costs relating to the prize; otherwise, the Organizer reserves its right to initiate any legal action it deems necessary against the said Participant.

3.0 Contest Period:

- 3.1 Unless otherwise notified by PLMM, the Contest will be conducted from 1 February 2026 to 30 April 2026 (“**Contest Period**”), both dates inclusive.

4.1.1 To join the Contest, Participants must:

- (a) Scan the QR code from the Point of Sales Material (POSM) available on the MyMesra webpage, PETRONAS Sprinta social media channels and at all participating PETRONAS Sprinta official distributors/dealers nationwide.
- (b) Complete the required personal details and answer the questions provided.
- (c) Upload and submit proof of purchase including but not limited to official receipt(s), on the website at <https://www.mymesra.com.my/qr/sprinta40>

4.1.2 In accordance with Clause 7 herein, Participants are required to fill in the requested details, including but not limited to:

- (a) Full Name (as per IC)
- (b) Email Address
- (c) Phone Number
- (d) Product Purchased
- (e) Purchased Quantity
- (f) Location of purchase
- (g) Upload purchase receipt

4.2 All entries must be received by PLMM within the Contest Period. Participants are allowed multiple entries with multiple receipts as proof of purchase, provided that each receipt meets the eligibility requirements and contest mechanics.

4.3 Purchases must be made via PLMM's distribution channels which are PETRONAS stations (Mesra Shop), PETRONAS Shop Official Store (Setel, Shopee or TikTok app), PETRONAS MotoExpert and at all participating PETRONAS Sprinta distributors/dealers nationwide.

## 5.0 Selection of Winners and the Contest Prizes

5.1 Successful Participants will be shortlisted by PLMM's randomizer system for the respective Contest Prizes based on the prize categories outlined in Clause 5.2, according to the total number of entries compiled by PLMM ("Winners Selection"). Compilation will be done based on the date, time, item(s) purchased, and amount spent as captured by PLMM. Successful Participants will be contacted by PLMM as outlined in Clause 5.3 and 5.4 herein ("Winners"). A total of Eighty-nine (89) prizes will be awarded as Contest Prizes to the respective Winners.

### 5.2.1 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> Prize ("Main Prizes")

- a) Winners Selection will be carried out after the end of the Contest Period.
- b) In accordance with the selection sequence by PLMM's randomizer system, the first three (3) shortlisted Participants will be deemed the final Winners, witnessed by the appointed authorized internal auditor.

### 5.2.2 Monthly Prizes

- a) Winners Selection will be carried out according to the following timeline:
  - Selection 1: 1 February - 28 February 2026;
  - Selection 2: 1 March – 31 March 2026;
- b) In accordance with the selection sequence by PLMM's randomizer system, the first forty-three (43) shortlisted Participants will be deemed the final Winners, witnessed by the appointed authorized internal auditor.

- c) Consolation Prizes will be credited into the respective Winners' Setel account within thirty (30) working days from the date of the Winners' announcement.
- 5.3 Winners will be announced and/or published on [www.mymesra.com.my](http://www.mymesra.com.my) or official PETRONAS Sprinta Facebook page (PETRONASSprintaAsiaPacific) or any other medium deemed fit by PLMM at its absolute discretion. Main Prizes Winners will be announced thirty (30) working days after the Contest Period ends. Monthly Prizes Winners will be announced seven (14) working days subsequent to the end date set forth in Clause 5.2.2(a).
- 5.4 For the Main Prizes, Winners will be informed through their registered email address and/or phone call via their registered mobile number within seven (7) working days from the date of the Winners announcement. Winners will be required to provide the requested personal details as set out in Clause 4.1.2 (a) for verification purposes.
- 5.5 For the Monthly Prizes, Winners will be informed through their registered email address and/or phone call via their registered mobile number within seven (7) working days from the date of the Winners' announcement. Winners will be required to provide the requested personal details as set out in Clause 4.1.2 (a) for verification purposes.
- 5.6 Only Participants who comply with these Terms and Conditions shall be eligible to win the Contest Prizes. Incomplete entries and/or Participants who fail to comply with these Terms and Conditions will automatically be disqualified from the Contest without further notice.
- 5.7 Should there be no response from the Winners for any reason, PLMM will make two (2) additional attempts to contact the Winners through phone call via their registered mobile number. Should there still be no response from the Winners after these two (2) additional attempts for any reason, the Winners will be disqualified from winning any of the Contest Prizes and PLMM reserves the right to shortlist the next-in-line successful Participants, who will then be contacted by PLMM via the same method outlined in Clause 5.8 below and may potentially be awarded the Contest Prizes as the Winners.
- 5.8 All Main Prizes will be awarded at a prize-giving ceremony organized by PLMM. Winners will be informed through their registered email address and/or phone call via their registered mobile number with instructions to attend the prize-giving ceremony. Winners must confirm their attendance prior to the prize-giving ceremony. In the event Winners are unable to attend the prize-giving ceremony for any reason, they must nominate a representative to receive the Contest Prizes on their behalf. The designated representative must bring an authorization letter from the Winner or a photocopy of the Winner's IC for the acceptance and/or collection of the Contest Prizes. PLMM reserves the right to disqualify any Winners if the Winners or their representatives are unable to attend the prize-giving ceremony, and PLMM reserves the right to re-select the Winners subsequently.
- 5.9 PLMM reserves the right to appoint a third party to conduct the verification of Winners and to fulfill the delivery of Contest Prizes to respective Winners. Winners agree that PLMM may provide information of Winners, including personal data to such third parties to facilitate such services.
- 5.10 All Contest Prizes are accepted entirely at the risk of the Winners, and PLMM excludes all warranties in connection with any Contest Prizes to the extent permitted by law. PLMM will not be held liable for the non-receipt of Contest Prizes or any loss or damage caused during the delivery process. No replacement and/or exchange of Contest Prizes

will be entertained under any circumstances.

- 5.11 In the event that a Winner chooses not to accept the Contest Prize(s), the Winner is deemed to have forfeited any and all claims to that Contest Prize(s). The Contest Prize(s) will then be handled at the absolute discretion of PLMM, including but not limited to the possibility of selecting an alternate winner or retaining the Contest Prize(s) for future use.
- 5.12 PLMM's decision on all matters relating to this Contest, including the selection of Winners shall be final, conclusive and binding. No enquiries, correspondence or dispute will be entertained. Unclaimed or unused Contest Prizes will not be extended.

- 6.1 PLMM reserves the right, at its absolute discretion, to disqualify any entries that are deemed ineligible or for any other reasons PLMM may deem fit. In the event a Participant is found to be ineligible at any time during or after the Contest Period, PLMM reserves the right, at its sole discretion, to disqualify the said Participant and to cancel, withdraw and/or recall any Contest Prizes won by and/or awarded to the Participant. If the said Participant has used or enjoyed the Contest Prize(s), the Participant agrees and undertakes to indemnify PLMM for the costs of such Contest Prize(s) and PLMM reserves the right to initiate any necessary action against the said Participant.
- 6.2 PLMM reserves the right at any time, at its absolute discretion and without prior notice, to substitute any Contest Prizes with items of similar or higher value. All Contest Prizes are given on an "As is" basis and are not exchangeable for or redeemable in cash, credit, other items or vouchers in part or in full and are non-transferable to any other person.
- 6.3 PLMM reserves the right to cancel, shorten, extend, suspend, or terminate the Contest at any time prior to the expiry of the Contest Period without prior notice to the Participants. For the avoidance of doubt, any cancellation, extension, suspension or termination of the Contest at any time prior to the expiry of the Contest Period shall not entitle the Participants to claim any compensation from PLMM for any and all losses or damage suffered or incurred by the Participants as a result of the said cancellation, extension, suspension or termination. PLMM also reserves the right to amend, modify, delete, or change any of the Terms and Conditions herein contained at any time, at its absolute discretion without prior notice. Continued participation in the Contest following any such amendments, modification, deletion or changes shall constitute the Participants' unconditional acknowledgment, understanding, agreement and acceptance of such amendments, modification, deletion or changes in respect of the Terms and Conditions.
- 6.4 PLMM reserves the right to use the names, addresses, photographs, information, and documents of the Participants as materials in advertisements and other forms of publicity for current and future marketing purposes from time to time without prior notice to the Participants and the Participants shall not claim ownership of the material. Participation of the Participants in the Contest constitutes their consent to such use, without further notice, payment, or consideration.
- 6.5 PLMM shall not be held responsible or liable for any injuries, damages, or claims whatsoever resulting from participation in the Contest, the use of the Contest Prizes, and/or the collection of the Contest Prizes. All transportation, accommodation, personal costs, and any other related expenses incurred in the participation of anything related to this Contest and/or redemption of the Contest Prizes are the sole responsibility of the Participants.

- 6.6 PLMM, its employees, its affiliates companies, employees of the PETRONAS group of companies, participating partners and its relevant service providers shall not be liable for any default due to any act of natural calamities, war, riot, strike, lock out, industrial action, fire, flood, drought, storm or any event beyond their reasonable control.
- 6.7 These Terms and Conditions prevail over any provisions or representations contained in any brochure or other Contest materials advertised under this Contest.
- 6.8 PLMM is the final authority to decide on the interpretation of these Terms and Conditions and any other matters relating to this Contest.
